## 背景

任何擬公開上映的電影都必須取得電影檢查監督(即電影、報刊及物品管理專員)的批准始可公映。我們的檢查員在決定送檢影片是否適宜公映和評定影片的級別時，都會考慮公眾人士的意見。為確保我們的檢查員了解公眾人士所能夠接受的電影尺度，以及讓市民參與評定影片級別的工作，我們根據《電影檢查條例》第6條設立了一個顧問小組。

## 電影檢查顧問小組

現時小組大約有三百名成員，來自社會各階層。他們都是義務參與小組的工作。他們每兩個星期出席一次在九龍長沙灣東京街西3號庫務大樓3樓電影、報刊及物品管理辦事處(電影報刊辦)舉行的檢片時段，在觀看影片後會就影片所屬級別向檢查員提供個人意見。我們的檢查員在評定影片級別時會充分考慮他們的意見。

## 申請辦法

## Background

Films intended for public exhibition have to be approved by the Film Censorship Authority, who is the Director of Film, Newspaper and Article Administration. In determining whether a film submitted is suitable for exhibition and its appropriate classification, our censors have to reflect contemporary community attitudes. To ensure that our censors are kept fully abreast of the current standards acceptable to our community and to allow public participation in the film classification process, a panel of advisers is established under section 6 of the Film Censorship Ordinance.

### Panel of Advisers on Film Censorship

The Panel now consists of about 300 volunteers from all walks of life. They attend film viewing sessions once every two weeks at the Office for Film, Newspaper and Article Administration (OFNAA), 3/F, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon. At the end of each viewing session, advisers give their personal views to our censors on the appropriate classification for a film. Their views will be fully taken into account when our censors classify the films.

### Application Procedures

From time to time, the Film Censorship Authority appoints suitable persons to become members of the Panel of Advisers on Film Censorship. Any member of the public aged 18 or above and proficient in Chinese and English may apply to be an adviser.
