In accordance with the Registration of Local Newspapers Ordinance (Cap. 268) (RLNO), every local newspaper shall be registered under the RLNO. The definition of "local newspaper" as stipulated in the RLNO is as follows -

Section 2: Interpretation

"newspaper" (報刊) means any paper or other publication and any supplement thereto available to the general public which-

(a) contains news, intelligence, occurrences or any remarks, observations or comments in relation to such news, intelligence, or occurrences or to any other matter of public interest; and

(b) is printed or produced for sale or free distribution and published either periodically (whether half-yearly, quarterly, monthly, fortnightly, weekly, daily or otherwise) or in parts or numbers at intervals not exceeding 6 months; and

(c) does not comprise exclusively any item or items specified in the Schedule;

"local newspaper" (本地報刊) means a newspaper printed or produced in Hong Kong;

<u>Guidance notes for completing forms in relation to local newspapers</u> <u>under the Registration of Local Newspapers Ordinance (Cap. 268)</u>

- (1) "Editor" means the chief editor if there are more than one editor and includes any person acting as chief editor or performing any of the usual functions of a chief editor. The particulars of the entry "editor" should relate to that of a person.
- (2) Other than the editor who must be a person, the particulars in respect of the entry "proprietor, publisher or printer" can be that of a company or other body corporate. In the case of a company or other body corporate, the company concerned should nominate a person to represent itself for the purpose of registration under the Ordinance. The particulars of this authorized person including name, I/D card number and signature <u>and</u> the company seal, should be included in the appropriate entry of the form.
- (3) The following supporting documents should be attached to the application form :-
 - (a) a photocopy of the latest Business Registration Certificate of the company concerned;
 - (b) a photocopy of certificate showing the latest particulars of directors of the company which acts as the proprietor of local newspaper;
 - (c) a certificate/letter authorizing a person to represent the company concerned which must be signed by 2 directors to that effect;
 - (d) a photocopy each of the identity card, passport, or other travel document in respect of the name of proprietor, printer, publisher, editor and authorized person(s) as shown in the application form; and
 - (e) a duly completed form in respect of the personal particulars of the informant.
- (4) A sample copy of a duly completed application form is attached for reference. The registration procedure will normally take 7 working days to complete upon receipt of the duly completed application form and necessary supporting documents. Applicant is advised <u>not</u> to publish his local newspaper until formal approval of registration has been granted.

(6) You may choose to receive registered particulars by electronic means. If you would like to receive e-copy of particulars of the registered local newspaper upon completion of registration, please inform us in writing (email: admnar@ofnaa.gov.hk) alongside your submission of required documents and provide us with your email address. Upon the completion of registration of the local newspaper, the e-copy will be sent to you by email, while the original will be sent to you separately afterwards.

- (b) to facilitate enforcement of the laws and regulations;
- (c) to facilitate members of the public to search for particulars of a registered newspaper / news agency / bulletin, or to search and make copies in accordance with the Registration of Local Newspapers Ordinance, Cap. 268 and its subsidiary legislation; and
- (d) to facilitate communication between Government and yourself on your application and other related matters.

2. The form must be completed in full. If you do not provide sufficient information, we may not be able to process your application.

3. The personal data you provide may be transferred to other Government branches and departments for the purposes mentioned in paragraph 1 above.

Personal Data (Privacy) Ordinance

Purpose of Collection

- 1. The personal data provided by you to the Office for Film, Newspaper and Article Administration in connection with matters under the Registration of Local Newspapers Ordinance (Chapter 268) will be used for the following purposes:
 - (a) to facilitate registration or renewal of registration of a local newspaper and news agency;
 - (b) to facilitate amendment of registered particulars of a local newspaper and news agency;
 - (c) to facilitate issue and renewal of newspapers distributor's licence; and
 - (d) to facilitate communication between Government and yourself on the above matters

If you do not provide sufficient information required by the said Ordinance, we may not be able to process your application.

Classes of Transferees

2. The personal data you provide may be disclosed to other Government bureaux and departments for the purposes mentioned in paragraph 1 above. Moreover, according to Section 10 of the Newspapers Registration and Distribution Regulations (Chapter 268B), any person may search, inspect and require copies of these registered particulars.

NEWSPAPERS REGISTRATION

ABRIEF NOTE OF LAW REOUIREMENTS OF LOCAL NEWSPAPERS AND PERIODICALS REGISTRATION

Subsequent to the registration of your local newspaper in accordance with the Registration of Local Newspapers Ordinance, you are to observe the following requirements :-

Registration of Local Newspapers Ordinance (Cap. 268)

- (i) A copy of every issue of the newspaper/periodical (including any supplement) shall be delivered to the Newspaper Administration Registry, within two days from the day of publication. The copy must be signed by either the printer or the publisher and it shall also bear the full name and address of the signatory thereof.
- (ii) The printer's name and address shall be printed either on the front page or the back page of the local newspaper.
- (iii) Any change in registered particulars should be reported to the Registrar of Newspaper Administration within seven days by furnishing the prescribed Form. The fee for official entry of substituted particular in the register is \$140.
- (iv) The first registration fee of publication is \$1,140 and the effective period is 1 year with effect from the date of registration. The registration should be renewed when it becomes due and the fee for annual renewal is \$895.
- (v) The registration of a local newspaper shall be deemed to have lapsed if it ceases publication for a consecutive period of more than six months.
